This is called 2 Sig Iron Condors. I have developed a tactic to make weekly profits in spite of the huge daily Up and Down movements in the SPX. SelfAdapSPXweeklyVLTy is the name of my software which I use to generate monthly income. The software described in this book uses only SPX for the options because I discovered that when I used other underlying stocks or indices such as Google and SPY, SPX usually finished best. Trade Monster's affiliate OptionsHouse can be used for Weekly Options trading if you have a minimum of \$2,000 in the account. I use 1/4 of the capital = \$500 for Margin to generate about \$100 for the week or \$400 for the Month. In other words you get 90% return per month on \$500 margin.
