Supply Chain Performance with A Target-Oriented Retailer

Problem definition: We study a supply chain with one supplier and one retailer. The supplier sets the wholesale price to maximize her profit, whereas the retailer is target-oriented and decides the order quantity to maximize his ability to reach a target profit. **Academic/Practical relevance:** Our work not only sheds light on the benefit/loss of trading with a target-oriented retailer, but also adds new knowledge to the supply chain coordination literature. It can also

potentially help unfold a new research direction in the supply chain management field on target-based decision making. **Methodology:** We provide strong support for firms' target-oriented preference and the linear target formation model through a survey as well as analyzing company data. With the retailer's target-oriented behavior evaluated by a cvar-satisficing measure, we apply a game theoretical framework to investigate how the retailer's target-oriented preference affects the supply chain performance. **Results:** With the retailer's target linearly dependent on his profit margin, we show that while the retailer is always worse off with his target-oriented preference, the supplier can significantly benefit from it and in some cases, she can reap the whole supply chain's profit. The supply chain can also perform better with a target-oriented retailer than with a risk-neutral retailer. A more interesting finding is that the target-oriented retailer can sometimes help the supply chain achieve the same efficiency level as in a centralized system, with just a wholesale price contract. We also investigate the role of information asymmetry and outside option in the performance of a supply chain with a target-oriented retailer. We find that both the information asymmetry and the outside option can alleviate the retailer's disadvantage of being target-oriented. **Managerial insights:** i) the target-oriented preference can be exploited by the trading partner and hence the retailer should adopt the target-oriented decision criterion with caution; ii) a target-oriented retailer can explore strategies such as hiding his target-oriented preference or revealing his outside option in order to be less manipulated and iii), whether a supplier/supply chain can benefit from having a target-oriented retailer depends on how ambitiously the retailer sets the target.
